**Presidential Elections Committee  
Decree no. 13 /2014**

On Forming a Committee to Monitor Abidance by the Regulations Governing  
Electoral Campaigns and its Finance

**The Presidential Elections Committee,**

Having perused:

The Constitution;

and Decree Law no. 22 /2014 on the Regulation of the Presidential Elections;

and Decree Law no. 1 /2014 by Presidential Elections Committee on the Rules  
Governing the Committee's Exercising of its Competences;

and Decree no.9 /2014 on the Regulation Governing the Finance of Electoral  
Campaign Electoral Campaigns;

and upon the approval by the Presidential Elections Committee on its session held  
on Saturday, 22<sup>nd</sup> of March, 2014;

**Decided:**

**Article (1)**

A committee shall be formed under the presidency of Judge/ Hussein Abd El-Raouf  
Zahran and the membership of:

1. Judge/ Mostafa El-Gabri
2. A representative of The National Council for Human Rights
3. A representative of The Public Authority for Investment and Free Zones
4. A representative of The Supreme Council of Press
5. A representative of The Egyptian Radio & Television Union
6. A representative of The Ministry of Awqaf
7. A representative of The Ministries of Administrative & Local Development
8. A representative of Public Funds Investigation Department
9. A representative of The Ministry of Education
10. A representative of The Ministry of Higher Education
11. A representative of The Ministry of Social Solidarity

Each Entity shall nominate its representative in the committee.

**Article (2)**

The committee shall monitor Electoral Campaigns stipulated in decree law no. 22  
/2014 and in the case of the occurrence of any violation the committee shall prepare  
a report to be presented to the Presidential Elections Committee, along with the  
suggested procedures that should be taken.

**Article (3)**

To perform its duty, the committee may demand any documents, papers, data or  
information that the committee deems necessary to conduct its tasks and also may  
inspect them through any governmental or non governmental entities or any relevant  
persons and requesting that they present them in the time specified by the  
committee. The committee may request assistance from any official entity or expert.

**Article(4)**

The committee shall convene by call of its head who assigns the issues to be presented in front of the committee, and who submits the reports to the Presidential Elections Committee.

**Article (5)**

This decree shall be enforced starting from the day following the date of its issuance and the concerned authorities shall be notified to implement it.
